If you have previously worked for the Program, only the 1st page of the application needs to be returned. Please keep in mind this is a 6/8 week commitment and individuals who cannot commit to the 6/8 weeks need not apply.

All 1st time applicants

Applicants must be 16 years old by July 1, 2024 and be enrolled in a full time high school or college program. Any applicant age 16 or 17 who is hired by Winthrop Parks and Recreation must get an application for an employment permit from the guidance office at their school. 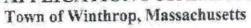
